

<u>3. STUDENT'S FEEDBACK ANALYSIS</u>

The survey results reflect a generally positive evaluation of various aspects of the college curriculum and facilities. Most students rated their understanding of the course material and its applicability highly, with 69% marking it as "Excellent" and 20% as "Very Good." Course employability received mixed reviews, with 45% rating it "Excellent" but a notable number (25%) rating it "Very Good" and some expressing lower satisfaction. Teaching methods were well-received, with 60% rating them as "Excellent". The courses usefulness for skill development also earned high ratings (62% "Excellent"), as did methods for curriculum enhancement through internships and seminars (70% "Excellent").

Continuous evaluation methods were rated positively, with 70% marking them as "Excellent." Practical subject facilities received good reviews, though slightly lower, with 65% rating them as "Excellent." The transparency in the evaluation process and timely course completion were also rated highly, with 73% and 70% marking them as "Excellent," respectively. Finally, course books and library facilities were rated very positively, with 74% marking them as "Excellent."



7. TEACHER'S FEEDBACK ANALYSIS

The survey data indicates a generally positive perception of the curriculum and syllabus. A majority strongly agrees that the curriculum is need-based (70%) and that course outcomes are clear (65%). Library resources are sufficient (62%), and the balance between theory and application is good (64%). The syllabus enhances knowledge (66%), and most are satisfied with achieving course outcomes (70%). However, there is mixed feedback on the freedom to modify the syllabus (45% strongly agree, 23% disagree) and adopt new teaching techniques (42% strongly agree, 16% disagree). College administration's support for slow learners is highly rated (72%), but contributions to curriculum development show less strong consensus (36% strongly agree, 23% disagree). Overall, the curriculum is well-regarded, with some areas for improvement.



11. EMPLOYER'S FEEDBACK ANALYSIS

The evaluation of college students working in the institution reveals a predominantly positive perception across various skill sets. For communication skills, 65% of respondents rated the students as excellent, and 12% as very good, indicating strong proficiency, though 15% rated it as fair, suggesting room for improvement. Knowledge levels were also rated highly, with 60% giving an excellent rating and 15% very good, but a noticeable 16% rated it as fair and 5% as poor. Ethical values and behavior received the highest praise, with 72% rating it excellent and only a small percentage rating it as poor.

Teamwork ability showed significant approval, with 70% rating it excellent and 22% very good, though 25% considered it fair, indicating a need for enhanced collaborative skills. The working style and learning ability of the students were highly rated, with 77% excellent and 12% very good, showing strong adaptability and work ethics, and minimal fair ratings.



15. ALUMNI'S FEEDBACK ANALYSIS

The feedback on the course effectiveness and relevance presents a mixed but overall positive picture. A majority (50%) strongly agree that the course was meaningful in their professional life. The process of revising course content also received strong support, with 50% strongly agreeing. Regarding the relevance of the course to current skill development and critical thinking, 50% strongly agreed.

The aims and objectives of the course were well-received, with 60% strongly agreeing. Availability of course materials was highly rated, with 70% strongly agreeing. Practical competency enhancement through the course was affirmed by 65% strongly agreeing. Relevance to job and industry requirements was acknowledged by 50% strongly agreeing, but equal percentages either agreed or were neutral.
